Academic staff in this position will also engage in administrative and service duties within the School as required and participate in professional activities related to their discipline.


The Murdoch Business School is comprised of two academic disciplines: Accounting and Finance and Management and Marketing.

## **Key Responsibilities / Duties**

- 2. Coordinate units, develop unit material and undertake course and program coordination. Develop and practice innovative teaching and learning methods
- 3. Consult with, and provide advice to, undergraduate and postgraduate students, including higher degree by research students.
- 4. Contribute to the research profile of the Discipline and the University. Contribute to research, individually and as a member of a team, and produce quality publications.
- 5. Contribute to seeking funding for internal/external competitive research and consulting activities, individually or as a member of a team.
- 6. Contribute to the University, the College, the Discipline and the profession.
- 7. Participate in the University's Academic Career Development Conversation (ACDC).
- 8. Undertake such other duties as determined by the Head of Accounting and Finance and the Dean of the Business School.

#### **Selection Criteria**

#### **Essential**

- 1. PhD in Accounting: Possess a doctoral degree in Accounting, demonstrating a strong academic foundation in the field.
- 2. Curriculum and Pedagogical Knowledge: Demonstrate contemporary knowledge of approaches to curriculum development and pedagogy.
- 3. Teaching Expertise: Relevant expertise in teaching across accounting disciplines, and foundational finance or economics subjects.
- 4. Research: Demonstrated success in engaging in and contributing to research, as evidenced by a proven track record of scholarly publications in reputable journals.
- 5. Grant Application Potential: Demonstrate potential capacity to produce grant applications, indicating the ability to secure research funding.
- 6. Teamwork and Initiative: Exhibit the ability to work effectively as a team member, while also being able to work autonomously under broad directions. Demonstrate initiative in undertaking responsibilities and a proactive approach to work.
- 7. Data Analysis: Demonstrated success in conducting data analysis for research.
- 8. Interpersonal Skills: Possess well-developed interpersonal skills and the ability to work collaboratively as a member of an interdisciplinary, collegial and community team.
- 9. Communication Skills: Display exceptional written and oral communication skills in English, showcasing the ability to effectively convey complex concepts and ideas.

#### Desirable

- 1. Teaching Expertise: Relevant expertise in teaching auditing and/or taxation, with demonstrated potential to teach in the area of sustainability reporting/accounting.
- 2. Industry Experience: Provide evidence of relevant industry experience as an accountant or a project analyst, to further enhance practical insights and industry relevance in teaching and research.
- 3. Accounting Software Proficiency: Exhibit experience or substantial knowledge in accounting processing software, such as MYOB or Xero, demonstrating familiarity with industry-standard tools and technology.
