

- 7. Consult with, and provide advice to, undergraduate, and postgraduate students, demonstrating the ability to create environments that foster learning to engage a diverse range of students.
- 8. Supervise Honours, Masters by Coursework, and HDR students.
- 9. Engage with, and contribute to the School, the University, the profession and the discipline.
- 10. Make a contribution to service within the School and University.
- 11. Participate in the University's Annual Career Development Conversation (ACDC).
- 12. Undertake such other duties as determined by the Head of School.

Selection Criteria

- 1. A PhD in an area relevant to appointment.
- 2. Experience in teaching in the discipline area.
- 3. Demonstrated ability to work under broad direction only, exercise initiative in undertaking responsibilities and work effectively as a team member.
- 4. Awareness of contemporary approaches to curriculum and pedagogy.
- 5. Evidence of producing high quality independent research outputs that have national/international impact, including recent publications of significance.
- 6. Evidence of success in attracting research funding.
- 7. Experience in the supervision of Honours, Masters, or HDR students.

- 8. Demonstrated industry links and ability to engage external stakeholders in teaching and research collaborations.
- 9. Well-developed interpersonal skills and the ability to work effectively as a member of an interdisciplinary and collegial team.
- 10. Demonstrated high levels of written and oral communication skills in English.

Work Requirements

- 1. Ability to work outside of normal office hours when required.
- 2. Australian permanent residency or possession of a valid visa with work entitlement in Australia.

Probationary Review

This position may be subject to a probationary period, during which time the academic staff member is required to meet set probationary objectives and pass a probationary review. Probationary objectives are set following appointment to the position and confirmed at the first Annual Career Development Conversation (ACDC).
