- First Nations: Become the University of first choice for First Nations peoples.

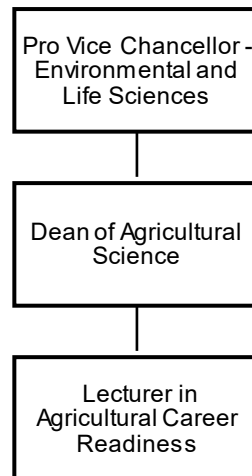
Murdoch is also committed to building engagement with our local community, State, Nation, and global society with a track-record in creating strong partnerships with business, government and industry.

Key Responsibilities / Duties

1. Contribute to teaching within the discipline, including unit coordination, preparing and delivering lectures, tutorials, seminars, practical classes, demonstrations, workshops and/or fieldwork.
2. Develop and practice innovative teaching and learning methods.
3. Build and maintain networks with government and industry partners for student work placements and internships
4. Provide academic oversight to for students undertaking work placements and internships
5. Contribute to the administration and oversight of the work placements and internships
6. Supervise students undertaking undergraduate, honours, postgraduate and HDR research projects
7. Consult with, and provide advice to, undergraduate, postgraduate and HDR students.
8. Apply for funding for programs that enable work placements and internships
9. Contribute to the School, the University, the profession, and the discipline.
10. Undertake broad administrative functions.
11. Participate in the University's Annual Career Development Conversation (ACDC).
12. Undertake such other duties as determined by the School Dean.

Selection Criteria

Essential

1. A PhD in an area relevant to the appointment
2. A broad knowledge of Australian livestock and broadacre cropping production systems
3. Demonstrated experience in teaching at the undergraduate levels including development and delivery of high quality learning activities, assessment and student supervision.
4. Demonstrated knowledge of contemporary approaches to curriculum and pedagogy, including reflective practice and work integrated learning
5. Demonstrated capacity to effectively engage with industry and government organisations
6. Demonstrated ability to work under broad direction only, exercise initiative in undertaking responsibilities, work effectively as a team member.
7. Well-developed interpersonal skills, demonstrated success in working effectively as a member of a team in a university environment.
8. Demonstrated high levels of written and oral communication skills in English.

Desirable

1. Demonstrated success developing and delivering work integrated learning activities for undergraduate and/or postgraduate students
2. Demonstrated experience and success contributing to unit coordination and design.
3. Established industry and government networks relevant to livestock industries, animal health, broadacre farming and/or biosecurity
4. Demonstrated success supervising student projects

Work Requirements

1. Australian permanent residency or possession of a valid visa with work entitlement in Australia.
2. Evidence of a criminal record check in accordance with the University's Criminal Record Screening Procedure
3. Ability to work outside normal office hours when required
4. Current and valid Australian C class Driver's Licence

Probationary Review

This position may be subject to a probationary period, during which time the academic staff member is required to meet set probationary objectives and pass a probationary review. Probationary objectives are set following appointment to the position and confirmed at the first Academic Contribution Development Conversation (ACDC).
