Murdoch is also committed to building engagement with our local community, State, nation, and global society with a track-record in creating strong partnerships with business, government and industry.


#### **About the Work Area**

#### **Key Responsibilities/Duties**

In conjunction with the relevant Program Supervisor, the Sports Official duties include the following:

- 1. Officiate and umpire specific sports competitions
- 2. Ensure safe and enjoyable social sport activity
- 3. Comply with OSH principles in regarding to playing facilities and conditions
- 4. Provide efficient management of scores and results
- 5. Effectively communicate with players
- 6. Undertake other activities which the incumbent might reasonably be expected to do, and which are consistent with the accountabilities and responsibilities as listed above.
- 7. Carry out, and assist with, other duties as required

#### **Selection Criteria**

#### **Essential**

- 1. Accredited referee
- 2. Effective verbal communication and interpersonal skills
- 3. Excellent negotiation skills
- 4. Current Working with Children Check

### **Desirable**

- Attainment, working towards, relevant qualifications or Certificate II.
- 2. Current Driver's License
- 3. Previous experience in a similar role
- 4. Current First Aid certificate

## **Work Requirements**

- 1. Australian permanent residency or possession of a valid visa with work entitlement in Australia.
- 2. Ability to work outside of normal office hours when required.
